Non-licensed architectural status with experience with California building codes. Oregon and/or Washington state also desirable.

- A Bachelor's degree in Architecture from an accredited program
- At least three to five years of project designer experience within a small to medium-sized firm/studio environment with at least two years of experience with assisting in highly technical project types, such as industrial, civic, commercial, multi-family, administration, operations, laboratory, maintenance, facilities, public works, or transportation facilities. Campus-type projects a plus.
- Proficiency in Revit, Bluebeam, 3D computer modeling, Adobe Creative Suite, SketchUp, and related programs
- Performs work to develop independent judgment in evaluation, selection, and adaptation of standard techniques, procedures, and criteria
- Receives technical guidance on unusual or complex issues
- Works with lead design architect to develop project concept through design and construction
- Some understanding of the technology used to produce documents and drawings to support project design
- Simultaneously handled and worked on the production of multiple projects as a trainee, technical assistant, and/or design assistant
